Public Work Class Environmental Assessment for the Proposed Ingleside Sewage Connection Project located at 15020 Long Sault Parkway, Ingleside, Ontario (1086849-272985)

WSP on behalf of the St. Lawrence Parks Commission (SLPC), has now completed the Consultation and Documentation (C&D) Report for the proposed Ingleside Sewage Connection Project located at 15020 Long Sault Parkway, Ingleside, Ontario (1086849-272985).

As described in the C&D Report, SLPC is proposing to connect four SLPC sites (McLaren Campground, Woodlands Campground, Woodlands Beach, including the Family Lodge, and Long Sault Trailer Dump Station) to the community of Ingleside water and sanitary municipal infrastructure, known as the Ingleside Sewage Connection Project (1086849-272985). A C&D Report has been prepared to address the works proposed at the four sites.

The properties are generally flat recreational areas, with a gentle southern slope towards the adjacent St. Lawrence River. They are located directly adjacent to the St. Lawrence River and consist of natural landscapes as well as developed lands including parkland, campsites, beach areas and associated infrastructure (e.g. washrooms, trailer dump stations, a lodge, a shower building). While the project will result in significant upgrades to site servicing, the landscape will generally be returned to its current form upon project completion.

This undertaking has been assessed as a Category B, in accordance with the requirements of the Ministry of Infrastructure Public Work Class Environmental Assessment. See Figure 1 for a site location map.

Requests to the Ministry of the Environment, Conservation and Parks

In addition, a request may be made to the Ministry of the Environment, Conservation and Parks (MECP) for an order requiring a higher level of study (i.e. requiring an individual/comprehensive EA approval before being able to proceed), or that conditions be imposed (e.g. require further studies), only on the grounds that the requested order may prevent, mitigate or remedy adverse impacts on constitutionally protected Aboriginal and treaty rights. Requests on other grounds will not be considered. Requests should be sent to the contacts below and include the requester's contact information and full name. A copy of the request must also be sent to the WSP contact above.

Requests should specify how it pertains to a constitutionally protected Aboriginal or treaty right, what kind of order is being requested (request for additional conditions or a request for an individual/comprehensive environmental assessment), how an order may prevent, mitigate or remedy those potential adverse impacts, and any information in support of the statements in the request. This will ensure that the ministry is able to efficiently begin reviewing the request.
